BOOKING RETAINER

\$80 (NON-REFUNDABLE) BOOKING RETAINER. UPON PAYMENT OF THE INVOICE, YOUR DATE IS BOOKED EXCLUSIVELY FOR YOUR WEDDING. WE WILL THEN SCHEDULE YOUR TRIAL.

BRIDAL TRIAL

A TRIAL IS INCLUDED IN YOUR BRIDE PACKAGE. PAYMENT OF \$100 IS DUE AT THIS APPOINTMENT. DOING A HAIR TRIAL ENSURES THAT I KNOW YOUR HAIR WELL, WE ARE ON THE SAME PAGE WITH DETAILS ABOUT YOUR DESIRED LOOK, AND YOU ARE COMFORTABLE IN MY GREAT HANDS ON YOUR SPECIAL DAY. TRIALS ARE RECOMMENDED JUST 1-2 MONTHS PRIOR TO YOUR WEDDING DAY SO THAT YOUR HAIR IS FRESH IN MY MIND. A TRIAL APPOINTMENT ALLOWS FOR 90 MINUTES. WE CAN DO ONE PRIMARY STYLE AND IF THERE IS TIME WE CAN TRY A COUPLE CHANGES OR ALTERNATIVE STYLES

ADDITIONAL TRIALS \$100

BLOWOUT

THE DAY BEFORE BLOWOUT IS INCLUDED IN YOUR CONTRACT FOR BOTH YOU AND YOUR 'PLUS-ONE'. COME AND HAVE A LITTLE PAMPERING TOGETHER BEFORE THE BIG DAY. THIS SERVICE IS NOT DISCOUNTED IF OPTED OUT. HOWEVER, IF THE APPOINTMENTS ARE UNAVAILABLE ON MY SCHEDULE, A \$40 DISCOUNT WILL BE APPLIED TO BOTH THE BRIDE AND THE GUEST'S TOTAL PAYMENT.

A WOMAN'S WEDDING DAY IS SO PRECIOUS AND PREPARING YOUR HAIR THE DAY BEFORE WITH A PROPER BLOWOUT IS THE BEST THING YOU CAN DO TO FEEL BEAUTIFUL AT THE REHERASAL AND

HAVE YOUR HAIR PREPARED WITH PROPER CLEANLINESS AND PRODUCTS FOR YOUR WEDDING DAY STYLE. THIS IS AN IN-SALON SERVICE AT MY LOCATION IN HANOVER, PA.

BRIDE WEDDING DAY STYLE

\$220. THIS IS THE REMAINING PIECE OF THE BRIDE PRICE TOTAL OF \$400 (THE FIRST HALF WAS PAID IN THE BOOKING RETAINER) THIS HALF WILL BE ON THE FINAL INVOICE.

THIS IS THE FINAL STYLE FOR THE BRIDE ON HER SPECIAL DAY. I ALLOW 90MIN FOR METICULOUS DETAIL AND PRECISION STYLING WHEN SHOWING UP FOR JUST YOU AND YOUR 'PLUS ONE'. THERE'S NOTHING LIKE SEEING THE STYLE COME TOGETHER WITH THE MAKEUP, JEWELERY, AND DRESS.

TRAVEL

TRAVEL FEES: \$2/MILE (EXAMPLE: \$40 FEE IF 20 MILES FROM SALON) FEE IS WAIVED IF LESS THAN 10 MILES.

YOUR 'PLUS-ONE:

ONE ALL-INCLUSIVE PACKAGE

\$200 THIS PACKAGE ONLY EXISTS FOR BRIDES WITH ONE SPECIAL BESTIE THAT THEY WANT TO BE A PART OF IT ALL WITH THEM. SO I WANT TO TREAT YOU! WHILE IT DOESN'T INCLUDE A TRIAL, I HOPE YOU GET TO JOIN US FOR THE BRIDE'S TRIAL

THIS PACKAGE DOES INCLUDE AN IN-SALON BLOWOUT THE DAY BEFORE THE WEDDING ALONGSIDE THE BRIDE & YOUR SIGNATURE STYLE ON THE WEDDING DAY.

I ALLOW FOR 60MINUTES TO TAKE MY TIME AND SECURE THE PERFECT STYLE FOR THE BRIDE'S PERFECT FRIEND ON THE WEDDING DAY!

WEDDING DAY EXPECTATIONS:

WET HAIR/BLOW-DRY FEE

ALL WEDDING DAY SERVICES ARE DRY HAIR STYLING. THIS SHOULD'T BE AN ISSUE IF WE JUST DID A BLOWOUT THE DAY BEFORE ANYWAY.

WEDDING DAY SCHEDULE & WEDDING DAY LATE FEES

IN ORDER TO BE EFFICIENT AND ALLOW TIME FOR EACH STYLE, ESPECIALLY THE BRIDE TO HAVE PEACE OF MIND THAT ALL WILL BE READY ON TIME... A DAY OF SCHEDULE WILL BE EXPECTED TO BE FOLLOWED.

HAIR PHOTOS

IN AN EFFORT TO MARKET FOR MY BUSINESS, I ASK PERMISSION TO TAKE PHOTOS OF ONE OR BOTH OF YOUR HAIR TO SHARE YOUR BEAUTY AND MY CREATIONS ON MY BUSINESS SOCIAL MEDIA ACCOUNTS AND POSSIBLY MY WEBSITE.

PLEASE BE SURE TO SEND ANY PROFESSIONAL PHOTOS FEATURING THE STUNNING HAIR TO MY EMAIL SO THAT YOU CAN BE FEATURED ON MY WEBSITE AND SOCIAL MEDIA.

CHANGES OR BRIDESMAID CANCELLATIONS

SPECIFIC DETAILS SHOULD BE LOCKED IN AT LEAST 60 DAYS BEFORE THE WEDDING, BUT I WILL DO MY BEST TO ACCOMMODATE AS ADJUSTMENTS NEED TO BE MADE.

IF YOU ARE INTERESTED IN ADDING ONE OR MORE STYLES, OR IF YOUR 'PLUS ONE' CAN NO LONGER JOIN YOU:

THERE IS NO FEE, AND I'LL DO MY BEST TO ACCOMMODATE THE CHANGES IF THERE'S MORE THAN 30 DAYS NOTICE.

IF THERE ARE LESS THAN 30 DAYS NOTICE, A FEE VALUED AT 50% OF THE CANCELLED SERVICE(S) MAY BE CHARGED.

ADDITIONAL WEDDING DAY STYLES ARE \$125 PER PERSON AND ONLY AN OPTION IF OUR TIMELINE ALLOWS FOR IT.

STYLIST INJURY, ILLNESS, UNPLANNED CIRCUMSTANCES

YOU'LL BE NOTIFIED AT MY EARLIEST KNOWLEDGE OF ANY CIRCUMSTANCE (HEALTH RELATED) THAT I AM UNABLE TO DO YOUR BRIDAL HAIR. IN THIS EVENT, I WILL CONTACT COLLEAGUES THAT I TRUST TO FIND COVERAGE. HOWEVER, YOU ARE WELCOME TO SEARCH ON YOUR OWN FOR A REPLACEMENT AS WELL

THE \$80 BOOKING RETAINER WILL BE REFUNDED, UNLESS YOU CHOOSE TO REMAIN WITH ANOTHER RADIANT HAIR DESIGNS STYLIST UNDER THIS CONTRACT.

FINAL PAYMENT

BOOKING RETAINER OF \$80 WILL BE SENT VIA INVOICE FROM MY BOOKING SOFTWARE, VAGARO. YOU CAN PAY THIS AT ANY TIME BY CARD BY FOLLOWING THE LINK.

TRIAL PAYMENT OF \$100 WILL BE DUE AT THE TIME OF YOUR HAIR TRIAL YOU ARE WELCOME TO PAY BY CASH CHECK OR CARD AT THIS APPOINTMENT.

FINAL PAYMENT:

FINAL PAYMENT CAN BE TOGETHER OR SEPARATE AND CAN BE PAID BY CARD VIA INVOICE OR AT YOUR BLOWOUT APPOINTMENT IN ONE LUMP SUM. CASH, VENMO, OR CHECK ON THE DAY OF THE WEDDING OR AT THE BLOWOUT APPOINTMENT IS ALSO ACCEPTABLE.

REMAINDER OF BRIDE PRICE & ALL OTHER STYLES AND TRAVEL FEES MUST BE <u>PAID IN FULL AT TIME</u> OF SERVICE ON THE WEDDING DAY.

UPON REVIEWING, I'LL FOLLOW UP WITH AN EMAIL AND IF YOU WANT TO BOOK WITH ME, JUST LET ME KNOW SO THAT I CAN SEND YOUR INVOICE YOU FOR THE BOOKING RETAINER.

YOUR PAYMENT OF THE BOOKING RETAINER INVOICE EQUATES TO:
